

To parents of children attending
municipal elementary schools

FY2025 Elementary School Lunch Subsidy Program Supported by Nagahama City

This system aims to create a town where people can raise children with peace of mind by having all citizens support the growth of the children who will lead the next generation, and it provides full subsidies for elementary school lunch fees, reducing the financial burden on parents raising children.

Parents of children enrolled in elementary school are required to apply for the subsidy, so please apply by April 14 Monday, 2025.

※Please do not forget to apply as applications are required every fiscal year.

1. Eligible recipients

Parents of elementary school children who live in Nagahama City

However, the following people are not eligible for subsidies.

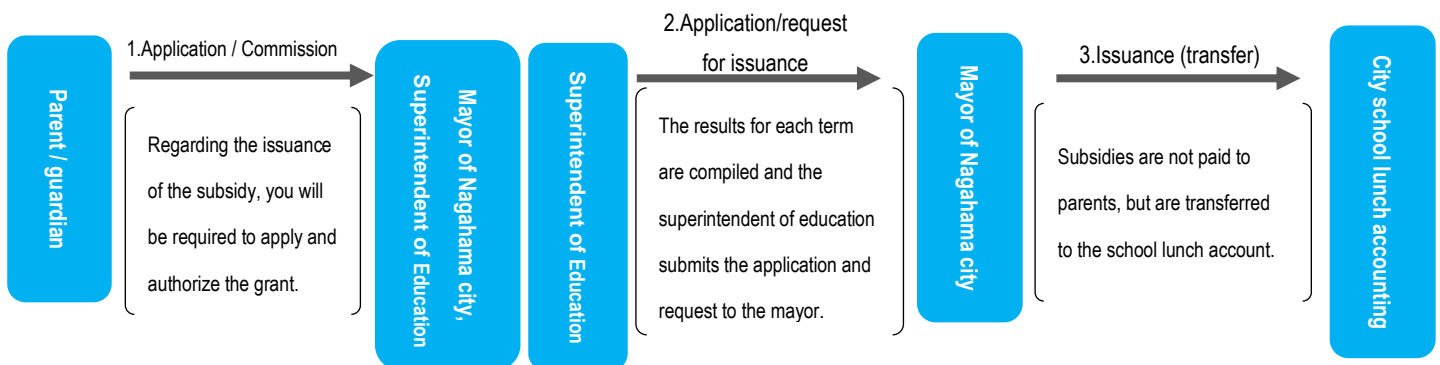
- If you are receiving school support or special needs education support
(※ If you are receiving special needs education support and have a self-paid share of school lunch fees, you are eligible for subsidies. See the back for details.)
- If you are receiving welfare assistance
- If the child is not receiving school lunches at his/her elementary school
- If you are in arrears with your school lunch fees

Elementary school lunch fees are supported by local residents, amounting to 4,500 yen per month and 49,500 yen per year per child.



2. Overview of the subsidy

Nagahama City will directly transfer the actual cost of school lunches (subsidy) to the city's school lunch fee category, so there is no need to pay school lunch fees to the city or elementary school.



3. How to apply for subsidy

Apply online (Kizuna Net form).

※For those who have difficulty applying online, paper applications (application forms) will also be accepted.

Please apply to your child's elementary school for the application form, fill it out, and submit it to your elementary school or the Sukoyaka Education Promotion Division.

Application forms can also be downloaded from the website.

4. Application period

By April 14 Monday, 2025

If you are currently applying for school assistance, special education support, or receiving welfare assistance

Please note that in these cases, the application procedures for assistance are different.

1. Those who are currently applying for school assistance

Those who are currently applying for school assistance (including those who plan to apply) must submit a subsidy application form regardless of whether or not they have been approved.

(※Notification of whether or not your school assistance application has been approved will be sent around the end of June.)

(1) If approved

The school assistance fee for school lunches will be transferred directly by Nagahama City to the city's school lunch fee category, so parents do not need to pay school lunch fees to the elementary school.

(2) If not approved

The school lunch fee (subsidy) will be transferred directly by Nagahama City to the city's school lunch fee category, so parents do not need to pay school lunch fees to the elementary school.

2. Those who are currently applying for the Special Needs Education Enrollment Incentive

Those who are currently applying for (or planning to apply for) the Special Needs Education Enrollment Support Grant must submit a subsidy application form regardless of whether or not they have been approved.

(1) If approved

As part of the school lunch fee will be received as a special needs education attendance encouragement grant, the remaining self-paid portion of the school lunch fee will be subsidized.

In addition, the special needs education attendance encouragement grant and the subsidy for the remaining self-paid portion of school lunch fees will be transferred directly by Nagahama City to the city's school lunch fee account, so parents do not need to pay school lunch fees to the elementary school.

(2) If not approved

Nagahama City will directly transfer the school lunch fee (subsidy) to the city's school lunch fee category, so parents do not need to pay school lunch fees to the elementary school.

※If your child's school lunch fees are fully covered by the national or prefectural special needs education support program, you will not be eligible for the subsidy.

3. Those who are receiving welfare benefits

Since you are receiving educational assistance for school lunch fees through welfare benefits, you do not need to submit a subsidy application form (you are not eligible for subsidy).
