9. Medical system for elderly / Kouki Koureisha Iryou

The "Medical system for elderly"-*Kouki Koureisha Iryou Seido* is one of the medical insurance systems for people over 75 and people between 65 and 75 who have a certain degree of disability.

◆Eligible (Insured person)

♦Qualification confirmation certificate

"Kouki Koureisha Iryou Hi Hokensha-shou" Late-stage elderly medical care qualification certificate will be issued if you take out this system. Please present it at the counter of the medical institution when you receive a medical treatment.

The eligibility confirmation certificate is renewed on August 1st every year. In addition, Qualification confirmation certificate will be sent to people who are about to become 75 years old by mail.

◆Premium

All insured persons must pay their premiums.

The amount of premium is determined according to the total of "Kintou Warigaku" per-capita amount and "Shotoku Warigaku" income-based amount.

The "per-capita amount" is borne by all insured people equally.

The "income-based amount" is borne according to their income of the previous year.

- *If your income is low, "per-capita amount" and "income-based amount" may be reduced.
- * If you were dependent of insured person of employee's health insurance plan, etc. "per-capita amount" may be reduced.

 Also, they are exempted from the "income-based amount".

♦How to pay the premium?

In principal, the premium is based on Special collection system-*Tokubetsu Choushu* (withdrawn from your pension automatically). However, in the case that the annual amount of your pension is less than 180,000 yen or the total premiums amount of "Long-term-care insurance (*Kaigo Hoken*)" and this "Medical system for elderly" exceeds 1/2 of your pension benefit, the premium collection is made with a regular collection system-*Futsu Choushu* (payment with payment slip, or payment by account transfer). In addition, those who just took out this system or those who just moved into Nagahama City must also make payment on regular collection system.

[Frequency of payments] * The deadline for payment of the normal collection is the end of each month (the following day if the end of the month is Saturday Sunday or a national holiday)

◆Your burden charge of medical expenses at medical institution

The self-pay rate at medical institutions is 10%, 20%, or 30% of medical expenses, depending on income.

◆To receive the following benefits, please make an application at *Hoken Nenkin-ka*, *Hokubu Godou Chosha Kurashi Madoguchi-ka* or each Citizen Service counter. .

When applying, please bring the necessary items as shown below in addition to Qualification confirmation certificate or the insured card.
